#### **GOODS REQUIREMENTS**

Each set diamond submitted for the Set Diamond Service must adhere to the following requirements.

- Colour colourless to near colourless (D-L)
- Size 0.0013ct, there is no upper limit
- Clean pieces containing dirty or greasy stones will be rejected and an INR 325 fee will be charged per piece. To avoid this stones should be cleaned with Ethyl Alcohol prior to being sent to the lab.
